## **Residential Concerns**

A survey was done because a resident believed Company property was encroaching their property. The Survey concluded that residential property west of the site was encroaching 10 feet – 15 feet on Company property. This was resolved by the Company designating this a green space.

Collins Road currently a private road will remove most truck traffic off of London Groveport Road.

The flooding issue will be addressed by dropping lime and concrete and installing storm pipes to push water to Retention Pond.

1280 London Groveport Road didn't have zoning hearing because it was zoned correctly.

Chief complaint of residents were that they were never notified.

Hamilton Township residents are not opposed to progress but feels the City and Company have not abided by South Side Accord Agreement.

No noise barrier for residence close to site. No barrier to shield near by residences from lights shinning into their homes.

One resident on west side of site facing truck docks is 15 feet away says he will be affected by lights shinning on his property and noise from trucks at the docks.

Residents said that because of construction, noise and dust prevented them from enjoying their yards and outdoors. Couldn't open their windows, use pools because of dust and noises.

Mr. Shannon said all buildings are up and he was close to leasing the site.
