#### **Z20-070 – HARTMAN FARMS REZONING**

Commissioner Walker requested a brief discussion about rezoning application Z20-070 for the Hartman Farms property. Commissioners shared concerns and questions about the proposed setback, mounding and screening, sound buffering, and lack of a site plan or known developer. Commissioners requested we explore alternatives for a site visit, in light of restrictions communicated about visiting the property. Commissioners also requested that representatives from the City attend a future commission meeting to discuss broader concerns about rezoning applications in this region.

A preliminary traffic study should be out before the Zoning Committee meeting on November 19.

#### **AREA COMMISSION TECHNOLOGY GRANT**

## **Committee Advisor Reports**

## **Internal Governance | Commissioner Draudt**

A request to purchase a tent, table and chairs for outdoor elections was not approved, because they fall outside of the description of allowable expenses. Commissioner Draudt is following up on this request with the Department of Neighborhoods.

## **Community Outreach | Commissioner Fisher**

Commissioner Fisher launched a neighborhood survey on our website. Ten responses from residents were received, reflecting safe neighborhoods and clean streets as priorities. Commissioner Fisher is working on a community engagement campaign and will be attending training in December regarding the city's new webpage for Area Commissions. She also plans to update our brochure.

## **Public Safety**

Commissioner Walcott reported on an Operation Safe Streets initiative that removed over 44 guns. Chair Richardson mentioned a new initiative from CelebrateOne, connected with Safe Routes to School.



#### **Environmental | Commissioner Neale**

Commissioner Neale reported on a meeting she attended about the City's Climate Action Plan and environmental justice. She also reported on her outreach to the City Attorney's Office regarding loud booms heard along South High Street; noise from the quarry and from the PSC company further north are in compliance with city code. Commissioner Neale provided updates on Ace Iron and Metal and the need for infrastructure improvements in the Cambria Community.

#### **Education | Commissioner Sherman**

Commissioner Sherman provided updates on area school districts offering remote, blended, or inperson learning, the Columbus City Schools Fuel Up! Meals program, and Learning Extension Centers. She also shared updates from Columbus Metropolitan Library, highlighting a program at the South High Branch involving Social Work interns from Ohio State.

## City Reports

Nancy Pryor Sully and Beth Fairman Kinney shared updates from the City and Department of Neighborhoods, primarily city-sponsored events occurring in the month of November.

Beth Fairman Kinney shared that Code Enforcement Officer Carl Yinger passed away. She also noted that a new cohort for Leadership Academy will be upcoming.

Commissioners asked Beth Fairman Kinney about the possibility of posting signage on properties that are under review for a zoning change. Beth is following up with Building & Zoning for more nformation.
