Zoning

Z20-060 – THORNTONS STATION – DERING RD. & SOUTH HIGH ST.

Eric Zartman with Underhill and Hodge shared a brief presentation regarding the proposed Thorntons Station at Dering Road and South High St.

Application Z20-060 includes requests to modify the commercial overlay, which doesn't work well for the setup of gas stations. Specifically, the request would:

- Increase building frontage, allowing the Thorntons store to be built in the back of the lot, with gas pumps and parking between the building and the street.
- Reduce the required building size from 60% to 40% of the parcel width (because this parcel is unusually wide).

Mr. Zartman took questions from Commissioners regarding the completed traffic study, signage, building design, and Thorntons practices related to safety and security.

Motion by Commissioner Walker to approve Z20-060 as amended. Seconded by Commissioner Fisher. Motion passes.

HARTMAN FARMS FOLLOW UP

Commissioner Walker shared that the Development Commission is hearing the Hartman Farms rezoning on January 14, and solicited any additional comments from commissioners.

UNFINISHED BUSINESS

Commissioner Richardson shared that she is working on getting bound Bylaws packets distributed. She also shared that the Far South Columbus Area Commission account at Staples, which allows for tax exempt purchases, is still under former Commissioner Watson's name and phone number. Commissioner Richardson will update the group when the account has been switched.

NEW BUSINESS

Commissioner Sherman acknowledged the recent killings of local residents Casey Goodson and Andre Hill at the hands of law enforcement officers, and asked how the Area Commission should continue the conversation about police violence and racism. Commissioner Richardson suggested a discussion at the February meeting.

Commissioner Draudt shared reminders for virtual meetings, and asked that Commissioners notify the group if they are leaving the meeting or stepping away. Commissioner Sherman suggested that Commissioners also review the display name on their Zoom account

Committee Advisor Reports

Community Outreach | Commissioner Fisher

Commissioner Fisher is updating the website with Committee Advisor reports and asked that they continue to be sent her way. Commissioner Fisher will continue to act as the host for regular Zoom meetings, and noted that she could also host a Zoom training for interested Commissioners.

It was requested that the website be updated to note current vacancies (1 open at-large seat, and 1 business seat). Commissioner Draudt clarified that the open seats cannot be filled until the next election cycle, and that appointments must be for one full year.

Resident Bruce Miller asked to speak about his interest in becoming a Commissioner, which was expressed at the November meeting. Commissioners discussed whether an exception to the Bylaws could be made; Mr. Miller chose to defer until the next election. Mr. Miller accepted the role of Public Safety Committee Advisor.

Environmental | Commissioner Neale

Commissioner Neale referred to her emailed report about Closed Loop glass. She also noted that she received feedback from fellow Commissioners regarding UIRF funding, and has had input on the collective application.

Education | Commissioner Sherman

Commissioner Sherman referred commissioners to her emailed report. She highlighted Columbus Metropolitan Library's increasing virtual programming, including the One Book, One Community series.

Zoning | Commissioner Walker and Commissioner Patterson

Commissioners Walker and Patterson noted that they have no Zoning applications at this time.
