Zoning CV22-113 4025 S. High Street Columbus, Ohio 43207 LDG Development:

This is the return of this project before the commission as part of the 2 step financing requirements as part of OHFA. The applicant provided the Commission an updated handout showing the changes to the site plan and the reduction in units from the original 300 units to 200 units. A question was asked about the affordability/price points and those are still to be determined by the additional funding that is in process (grant money from OHFA). COTA has still not committed to any updates or changes or held any meaningful discussions about mass transit to this property to handle commission questions/concerns even after follow up after previous meetings. Discussion was held about the reduced parking spaces request and the insect control as it relates to the mosquitoes and the wetlands that are behind this property and the initial promise of screening the outdoor decks/patios.

Graphics Commission GC22-026 3900 S. High Street Columbus, Ohio 43207 Turkey Hill:

The applicant brought an updated signage plan with him to the meeting and a video of the video sign that had community and commission concerns, as well as concerns expressed by the Scioto Southland Civic Association. The video was viewed and found to be acceptable to all. The city wanted a monument sign; however the applicant wanted a similar sign to the existing sign, just updated to be electronic and not manually changed numbers and letters. The applicant felt a monument sign would place them at a disadvantage, considering that on two other corners at this intersection, full sized signs either exist or are being constructed for gas station operations. It was noted that the Scioto Southland Civic Association voted their support for this sign and sent a written letter to the Area Commission as such.

FACCES: Mr. Jordan Cartwright gave a presentation about the FACCES program, the services they provide and how the Area Commission and our community can interact with their agency. Discussions centered around pre-school education, food delivery, educational opportunity, housing issues, young persons leadership development and childcare. Physical Wellness, Legacy Development and Mental Health are also 3 of their pillars as well. A large amount of info was shared, and brochures and handouts are available.

Applicant for vacant Area Commission seat Sheronda Byrd: Ms. Byrd is a real estate investor and real estate broker who owns her own brokerage here in Columbus, Ohio and in the Atlanta, Georgia area. After a question-and-answer session it was determined that she would be most appropriate for an at large seat, as her physical office is outside of the area commission boundaries. She is a Marion Franklin High School graduate, and she currently resides in Alum Crest Acres.

The applicant has not sent her biography to the Commission chair, and the members of the commission have not been able to review her biography. The applicant was asked to return to the January meeting and to send in her biography before the January meeting so that the proper review can be done by the chair, and she will be considered at that time.

AEP: There are 2 separate discussions about AEP:

Item 1. Matthew J. Smith is the new leader on the Parsons Avenue Power Tower removal Project. AEP through Mr. Smith has notified the commission that the timeline for removal has been moved up from our last conversation with AEP. The new start date for removal is survey crews starting immediately with a February/March 2023 start date.

Item 2. AEP has come to Commissioner Miller as the point of contact with the commission as it relates to the tower removal and requested letters of support for a power outage abatement program. Commissioner Miller was a conduit for our area in referring individuals during the summer power outage to IMPACT community action agency and to the AEP neighbor to neighbor program for financial assistance during the power outage crisis due to his pre-existing relationship with AEP. Now AEP wants “community leaders” to sign on to a potential plan that would provide back up generators, battery storage devices, microgrids and large-scale generators for our area, but with this comes a power rate increase and costs to the City of Columbus potentially, in the documents provided. Commissioner Miller feels that the whole commission needs to weigh in on this and it is unfair for AEP to ask him to solicit resident and community leader feedback on this and is bringing it to the commission for their input and guidance.

Motion made by Commissioner Fisher to table any action on AEP and their request for a letter of support until our January 5, 2023 meeting to allow research time into their request; Seconded by Commissioner Eubanks.
