Zoning Application Z21-093 for 3075 S. High Street: Applicant or their representative did not show up to the meeting.

Zoning Z21-081, Lockbourne Road Rezoning to L-M:

Applicant Donald Plank presented the informational changes that occurred to the limitation text after the Area Commission voted on this zoning application and the application was heard at the City of Columbus Development Commission Meeting on 12/09/2021 and new revisions to Limitation Text developed from that 12/09/2021 hearing as well as to the site plan as it relates to the historic cemetery and screening and buffering along the property lines. Members of the Area Commission asked numerous in-depth questions of the applicant as well as numerous members of the public and officials from neighboring municipalities.

Committee Reports

Recreation and Parks:

Presentation from Columbus Recreation and Parks on the New Stockbridge Park:

Tina Mohn from Columbus Rec and Parks gave a presentation to the commission that included a site plan with detailed planting designs, maintenance schedules, layouts and other details for the new Stockbridge Urban Forest. This project is being funded through a Federal/State combined grant and will not only be an educational opportunity for our residents but also students from the Forestry Department at Ohio State University. This is a new concept for Rec and Parks which includes design elements to reduce ATV traffic/redirection onto appropriate pathways. Major work will begin in early Spring of 2022 weather conditions permitting.

Health and Human Services: No Report

Community Outreach: Commissioner Fisher presented the new Area Commission brochures which were well received by the membership.

Environmental: Commissioner Neale introduced her invited guest Assistant City Attorney Steve Dunbar. He provided an update on ACE Iron and Metal and the concrete landfill. Commissioner Neal represented the Area Commission in front of Judge Mingo at Environmental Court to inform the court just how ACE has impacted the community and did a fantastic job per City Attorney Dunbar. The remediation process continues at ACE on a court set schedule. The concrete landfill is a far different story. They are on their 3rd contractor to attempt the removal of concrete and they are in violation of the court-imposed schedule to have this work in process. January 10, 2022 is the next court status conference. Commissioner Neale will keep the commission apprised of the situation. There was discussion related to the new senior housing and the concrete landfill being in close proximity to the housing and the impact this could have on the new senior development. City Attorney Dunbar promised to return every 60 days to update the entire commission on the status on both properties.

Old Business:

Lynette Davis, a resident of the Fairlane Mobile Home Park spoke to the members of the Area Commission about issues with homeless individuals who are living in large camps on land to the North and west of the Mobile Home Park. To access their camps the homeless are driving through fences erected by the mobile home park to separate their property from the neighboring property and destroying them. In addition, there are issues with large amounts of trash, discarded syringes, theft, vehicle damage, crime, and fires being set. Ms. Davis was connected to Christopher Clark, Beth Fairman-Kinney and other city resources including the police neighborhood liaison officer for assistance.

New Business:

Appointment of Sheila A. Eubanks to vacant seat: Ms. Sheila A. Eubanks has submitted her biography and photograph to the Area Commission and requested appointment to a vacant at large seat on the far South Columbus Area Commission. The floor was opened to commissioners to ask Ms. Eubanks questions, and several were asked. Upon completion of the question-and-answer session a question was asked about the seat Ms. Eubanks would be occupying. Her seat is the seat listed as beginning January 1, 2022 and ending on December 31, 2024.

Motion to appoint Ms. Sheila A Eubanks to a vacant seat on the Far South Columbus Area Commission with a term expiring on December 31, 2024, made by Commissioner Walcott and seconded by Commissioner Smith.
